K FAMILY GROUP

**QUESTIONS CONCERNING THE K FAMILY GROUP
SHOULD BE DIRECTED TO A CENTER**

The K FAMILY GROUP has determined that, for many families, the most basic “medical care” needed is to be able to feed and clothe the family members.

Thus, the K FAMILY GROUP is preparing to have provided, to Internet Catalogue Club Members that have registered as part of K FAMILY GROUP, \$500 USD per week.

These funds may be provided by each registered Member receiving a pre-paid debit card for that amount each week.

The funds thus made available are being provided to enable the Member to pay for:

- 1) Health care for family members, plus for their pets and farm animals.
- 2) Health care insurance that the family may select.
- 3) Food and clothing as the family may need.
- 4) Other basic family needs.
- 5) Needs that the family may see others in the community or in the world may have.

Periodic audits should be expected and, in the event funds provided are found to be used inappropriately, at the sole discretion of K FAMILY GROUP funding may cease.

Families faced with catastrophic medical expenses may contact K FAMILY GROUP at kfg@change2100.com and special negotiations may provide solutions.

What has made this possible is UNIFORM ADVERTISING.

Any Member of the Internet Catalogue Club can register as a Member of KFG by sending a registration request, including their Club number to kfg@zcash.org

KFG will place the Member on a list to await a “uniform”.

The “uniform” designed by KFG may be the pre-paid debit card, with six logos and six websites displayed thereon.

As funds become available, on a first registered, first served basis, the “uniforms” will be provided.

SPONSORING

Income from sponsoring other Members may be reviewed in NEWS YOU CAN USE 7004 and 7014.

Sponsoring income may be obtained by sponsoring Members to use the “uniforms” and/or by sponsoring Members (businesses) that advertise through the “uniforms”.

ADVERTISING

To provide a “uniform” weekly, for 50 weeks, would cost advertisers \$1,000,000 USD.

Payment may be made:

- 1) With cash funds;
- 2) Or, using “MORTGAGE BUSTING TEAM MEMBERSHIPS” (“MBTM”) valued at \$10,000 USD and obtaining and paying with a \$1 M Promissory Note.

If payment is made using a Promissory Note as indicated, negotiations must be engaged with the LAW FIRM that issued the PRESS RELEASE in BUSINESS TIP 0045.
